TEMPERATURES SOAR

Hot, humid Summer triggers increased cooling needs and higher utility bills

Customers opening recent MLGW bills have noticed higher electric charges, based on higher consumption attributed to cooling. According to www.AccuWeather.com, local temperatures in the month of June averaged three degrees higher than normal, while July was two degrees higher than normal and, August is expected to exceed normal ranges as well.

Heat advisories have been issued many times, triggered by high temperatures and humidity which increases the potential for dangerous heat-related illnesses.

All these factors result in longer operation of air conditioning equipment. To minimize the impact of cooling needs—and costs—this Summer, consider these actions:

- Adjust your thermostat settings to limit run times as much as feasible. This means raising temperatures a couple degrees during operating hours and several more degrees once your business closes. A building management system or programmable thermostat can automate these adjustments. Learn more at:

- Utilize personal fans at desks and box fans in areas where employees congregate, as fans provide low-cost cooling by stirring the air to speed moisture evaporation from the skin. However, fans don't actually lower the temperature, so turn off when leaving the area.
- Use window coverings, especially on the west side of your building during afternoons. Encourage employees to close blinds in individual offices and other spaces.
- Limit lighting in seldom-used spaces, such as conference rooms, break rooms and rest rooms. Light fixtures produce heat, which adds to your cooling needs.

- Turn off unnecessary office equipment and appliances after use. This includes coffee pots, televisions, radios, desk lighting, computers, monitors, printers and copiers all of which use electricity and produce heat through their

MLGW restores partial power to damaged Arlington substation

MLGW has completed partial restoration to Substation 68. As a result of the restoration, customers served from Substation 68, which includes Arlington, Lakeland and a portion of Bartlett, can resume normal electric consumption between the hours of 3:00 and 8:30p.m. The request for energy curtailment and concern of possible rolling blackouts has ended.

The fire at Substation 68 in the wee hours of 7/11/2016 was an unprecedented event for MLGW. Customers in the vicinity responded to voluntary conservation efforts which, combined with key employees working around the clock, allowed the utility to isolate the damage and complete partial repairs to the substation two weeks ahead of the originally projected date. While MLGW reconfigures the available electrical circuits from Substation 68, customers may experience temporary outages over the next few weeks. MLGW expects total restoration to Substation 68 to take up to six months.

MLGW thanks all of its customers for their sacrifice and patience during this time.
