## TVA announces application details for 2017 renewable generation programs

Customers interested in installing renewable power generation systems at their facilities have new opportunities in 2017. TVA offers two incentive programs that will re-open for applications next year.

### Green Power Providers

Program designed for businesses, organizations and residents who want to invest in small-scale projects, ranging from 0.5 kW to 50 kW. Green Power Providers offers a 20-year agreement to buy 100% of power output at the E-2 part 1 electric rate. The program opens for applications on 1/11/2017. There will be 10 MW of capacity, split evenly between residential and business customers.

### Distributed Solar Solutions

Program is a competitive process for larger solar projects, up to 2 MW each. TVA buys 100% of output at avoided cost plus premium of \$0.0273 per kWh. Project must show innovation in targeted deployment, financial model or community solar. Companies must gain MLGW support prior to submittal, so if you are considering please notify us of your potential project soon. Application available 1/11/2017, but must be submitted by MLGW between 3/1/2017 and 3/15/2017.

## EnergyRight Solutions for Business and Industry incentive recipients to receive IRS 1099 forms in January

TVA is responsible for reporting income other than wages, salaries, and tips to the Internal Revenue Service (IRS), including EnergyRight Solutions for Business and Industry (ERSBI) incentive payments.

The IRS requires 1099 forms be sent directly to the party listed on the incentive check, which means ERSBI participants earning a program incentive in 2016 should receive the forms by 1/31/2017. 1099 forms will be issued and distributed by Lockheed Martin, TVA's program administrator, on behalf of TVA.
