Mayor selects new MLGW president

After an extensive national search, Memphis Mayor Jim Strickland selected J.T. Young, Gulf Power general manager of customer service and marketing, as the 11th president of MLGW.

Young joined the Southern Company, parent of Gulf Power, in 1989. He has served as Industrial Marketing Manager, Pensacola District Manager and Southern Company's Chief Information Officer for Gulf Power. Prior to that, Young worked as a distribution and marketing engineer at Progress Energy Florida (now Duke Energy, Florida) and as a systems engineer at a TVA nuclear plant in Alabama.

Young, who was confirmed by the Memphis City Council in January, will join MLGW on 3/19/2018 to fill the post previously held by Jerry Collins Jr., who retired on 1/31/2018.

MLGW CFO Dana Jeanes will manage daily operations as Chief Utility Officer until Young arrives. Under the utility's charter, the interim president and CEO will be MLGW Board Chairman Steve Wishnia.

Memphis City Council approves MLGW 2018 budget

After a long and arduous process that began in November and included presenting eight different rate options, the Memphis City Council approved MLGW's 2018 budget on 2/6/2018.

The \$1.95 billion operating and capital budget includes muchneeded increases for electric and gas service, beginning with meters read in the July revenue month. A 1.05% water rate increase was approved 1/9/2018 to fund a study of the aquifer system from which MLGW draws its water. Watch for details.

Frigid weather triggered high electricity demand across region

It takes a good mix of power generation for the Tennessee Valley Authority (TVA) to serve the Valley's energy needs on a very cold day. The peak demand on Wednesday morning, 1/17/2018, was officially 31,639 megawatts—the twelfth highest winter peak



on record. But Thursday, 1/18/2018, beat it out, coming in at the sixth all-time winter spot with 32,513 megawatts at its peak load. On 1/17/2018, TVA set an all-time daily record of 706 gigawatt-hours delivered, which is enough electricity to serve all of New York City for 64 days.

Ensuring sufficient power supply to meet high demand required a mix of generation resources and demand response. For example:

- TVA called EnerNOC Demand Response events on 1/17/2018 and 1/18/2018, from 5am to 10am Central. Participating businesses in Shelby County and across the region were notified to reduce energy use according to their demand response plans. (Although the EnerNOC Demand Response program is more commonly deployed to offset Summer peaks, TVA called half of the program's annual 40-hour maximum in January.)
- TVA issued Electric Load Curtailment alerts, asking all customers to minimize electricity use, especially during peak hours. Due to the high penetration of electric heating across the region, TVA's Winter peaks occur in the morning (typically between 5am and 10am Central). Although roughly 80% of Shelby County households have natural gas heating, which does not have the same impact on TVA's Winter peak, every customer can assist by reducing non-essential power use.
- TVA activated natural gas combined cycle plants, which provide fast-starting power to supplement TVA's baseload generation. These plants can be operational in 12 minutes and delivering maximum output in less than 20 minutes, making them good resources for extremely cold and extremely hot weather. - TVA was able to utilize minor amounts of solar and wind generation, as the peak hours occurred in the predawn and morning hours, when renewable generation was at its minimum.



Four nominees confirmed to TVA board by U.S. Senate

The U.S. Senate confirmed the nominations of four individuals to fill open seats on the nine-member TVA board of directors. Each was nominated 9/21/2017 by President Donald J. Trump. The individuals were sworn in at ceremonies in mid-January. The new board members join current board members Rod Walter (Memphis), Virginia Lodge and Eric Satz (both from Nashville) and Richard Howorth (Oxford, MS).

The four new TVA board members are:

• Kenneth E. Allen of White Plains, Kentucky. Allen was most recently executive vice president of Operations and chief operating officer at Armstrong Coal Company, Inc. Previously, he was vice president of Operations.

- A.D. Frazier of Mineral Bluff, Georgia. Frazier has been an executive manager in the for-profit, not-forprofit and government sectors during his entire 35-year career. His executive leadership roles include chief operating officer and second-in-command of the Atlanta Committee for the Olympic Games, president and CEO of INVESCO, Inc., chairman and CEO of Danka Business Systems, chairman of the board of Gold Kist, Inc., president and COO of Caremark Rx, Inc. and chairman of the board and CEO of the Chicago Stock Exchange.
- Jeff W. Smith of Knoxville, Tennessee. Smith is the executive vice president for Operations for UT-Battelle, LLC, and deputy for Operations at Oak Ridge National Laboratory. While at ORNL, Mr. Smith has led a \$400 million modernization effort that has given rise to more new construction at the Laboratory at any time since the Manhattan Project.
- Mr. James R. "Skip" Thompson, III of Decatur, Alabama. Thompson currently is president and CEO of Corporate Billing LLC in Decatur, Alabama, a subsidiary of National Bank of Commerce, Birmingham. Previously, Thompson served as president and CEO of First American Bank in Decatur, and was president and CEO of First Commercial Bank in Huntsville, Alabama.

The terms for Allen and Thompson will expire in 2021. Smith and Frazier, whose terms will expire in 2022, replace outgoing TVA board members V. Lynn Evans, owner of a Memphis certified public accounting firm and former MLGW board member, and Marilyn Brown, a professor at Georgia Institute of Technology.

Walter is president and general manager of WREG-TV and a former Vice President of a Customer Relations and Assistant to the President at MLGW. His TVA Board term expires in 2019.

TVA is MLGW's sole wholesale provider for electricity.
