## Energy Right Solutions for Business helps customers save big money on utilities and reduce project payback with rebates

In the last 12 months, MLGW customers have completed energy efficiency projects that cut electric demand by more than 3,000 kW, slashed consumption by 18,201,400 kWh—and earned nearly \$1.5 million in TVA Energy Right Solutions for Business rebates!

TVA recently modified the Energy Right Solutions for Business and Industry programs to further streamline the application process.

- Expands the "Standard Rebate" application to incorporate additional lighting retrofit options, including some LED retrofits. Motion sensor incentives have been added with the removal of maximum wattage requirements for replacements.
- Allows Preferred Partners Network (PPN) members to submit lighting upgrades using the "Lighting Workbook." This gives the PPN members an edge over non-PPN members by possibly being able to access more incentive dollars via the Lighting Workbook.
- Eliminates the pre-inspection requirements for the Standard Rebate HVAC projects.

SFI of Tennessee replaced 1,460 lights in their facility at 4768 Hungerford Road. In addition to the rebate, SFI will save on their monthly energy costs as a result of replacing metal halide and T12 lamps with T8 and T5 lamps and adding lighting controls.
