PHISHING SCAM

Criminals send bogus emails to steal information and corrupt your computers

In late February, an MLGW customer contacted us to inquire about a suspicious email, purportedly from MLGW, stating a bill amount that was different than his actual MLGW bill. Thanks to this alert customer, we now know that there's a new form of utility fraud circulating in Shelby County—called "phishing". It's not a leisurely recreational activity, but rather an attempt to infect your computer with malware when you click links or open attachments in bogus emails.

Pacific Gas & Electric, Portland General Electric and Atmos Energy customers also reported this scam. Details have been emerging since January, with reports at http://www.snopes.com/fraud/phishing/pge.asp

The MLGW customer who was contacted forwarded his bogus email, which is shown below.



Clues that this email is bogus:

- 1. "Gas Usage Statement" is an odd title for MLGW to use, given that we provide three services
- 2. Account Number is not MLGW's 16-digit number. (In MLGW's My Account bill notification emails, a portion of the account number is shown as asterisks, while another portion is shown as numerals.)

- 3. Grammatical errors are extremely common in bogus emails. (We're not saying that you'll never find an error in an official email, but the odds are low!)
- 4. No reference to MLGW, My Account, MLGW customer service numbers or anything utility-specific (although those details can appear in bogus emails, too).

Protect yourself and your business! If you receive such an email, delete it immediately and do not click on any links or open any attachments. The most secure way to access your MLGW information is online via MLGW's My Account service. Type the URL (www.mlgw.com) directly into your browser and then click My Account to login using the ID and password you created. You will be able to view your bill, pay your bill, analyze your bill, see bill inserts and find other account information.
