#### **Spring into Safety**

Spring is almost here, and with the change of seasons, severe weather may visit us. MLGW wants you and your family to be safe during severe weather outbreaks, so here are a few tips to keep you safe:

- · Identify the safest place in your home in case of emergency. It might be a closet or bathroom in the middle of your home, as far from windows and exterior doors as possible. Go and stay there if you hear severe weather warnings in your area.
- · Stock that room with emergency items such as a first aid kit, flashlights, a battery-operated radio or TV, and extra batteries.
- Store either bottled or tap water in sterile containers, enough for several days, two quarts per person per day. Store some non-perishable food items that don't require heating, as well as a can opener.
- Include a whistle or similar device to alert emergency personnel in case of rescue efforts.
- Store a supply of necessary prescription medicines.



# When Severe Weather Strikes, Remember these Safety Tips:



- Never approach or touch downed power lines. If a power line falls on your car, remain inside the vehicle, call for help, and do not get out until help arrives.
- Know how to turn off your gas, electricity and water in case the lines are dam-
- If you smell gas, do not turn on lights or electrical appliances or use a phone, or any source of flame or spark. They could cause an explosion.
- If you smell gas after damage from severe weather, leave the building immedi-

- ately. Go to a safe place and call MLGW. Do not go back into your home until an MLGW representative says it is safe to do so.
- If you use a portable generator, do not operate it inside your home due to carbon monoxide danger. Also, do not plug it into a wall outlet to power your home; that can cause a fire hazard.
- Should you have downed wires, gas leaks or a broken water main, call MLGW's 24-hour, emergency-only hotline at 528-4465.

# Be Shovel-Ready. Call 811 Before you Dig!

It's tempting to break ground in your eagerness to start an outdoor project like building a fence or planting a tree. But do you know what lies underground where you plan to dig? Natural gas pipelines and other utility lines weave beneath the surface throughout our community. Major gas pipelines are marked with a yellow caution sign. But secondary lines aren't as easily identifiable. Don't risk hitting a gas line, disrupting neighborhood service, and facing potential fines and repair costs. Before you begin digging, contact Tennessee One Call at 811 to request that a professional locating crew mark the underground utility lines on your property. The service is free, and it is federally mandated.

## **Gas Pipeline Safety**

Besides being prepared for the dangers of severe weather, some knowledge about natural gas safety is critical. It is important to know what to be prepared for in case of natural gas transmission pipeline problems.

- Be aware of where natural gas transmission pipelines are located in your area.
- If your home is close to a major gas-supply pipeline, you should know what to do and where to go in case of a pipeline emergency.
- When warned to evacuate the area, do so immediately.

- Almost 60 percent of natural gas pipeline accidents are caused by damage from excavation or construction. Other causes include rare damage by vehicles or corrosion.
- Whenever you plan to dig on your property, check to see where your home's underground gas lines are located, even for spring planting.
- Call Tennessee One-Call first in order to have your underground gas (and electrical) supply lines located and marked. Failure to do so could result in an explosion (or

- electrocution). Plus, it's the law.
- Simply call 811 at least three days before you plan to dig to arrange for a representative to come out and mark the location of your underground pipes and cables. Don't dig until they have done so.
- For gas appliance safety, make sure your gas appliances are properly vented and inspected annually by a licensed professional.

#### **MLGW Earns AHA Gold**

The American Heart Association (AHA) recently honored MLGW as one of Memphis' pro-health employers. Lindsey Bailey Harmon, Heart Walk's Senior Director for AHA, presented the Gold Fit-Friendly Award at a recent Board of Commissioners meeting.

Promoting a wellness culture, offering physical activity support and providing nutrition activities were reasons given for MLGW earning the award. "MLGW has an exceptional culture of employee health and wellness that all other companies in our community would benefit from by incorporating similar initiatives into their organizational cultures," Harmon said.

#### **MLGW's LNG Sales Could Benefit Customers**

Memphis Light, Gas and Water Division's President and CEO Jerry Collins Jr. reported recently that the utility is using its ability to liquefy and sell natural gas for additional revenue, and this move could help reduce the heating bills of local residents.

MLGW has been able to sell the liquefied natural gas (LNG) for 60-80 cents a gallon to other companies, which in turn distribute the resource at truck stops. There, the liquefied natural gas is sold as an alternative fuel for 18-wheelers.

"It's been popular because the price is substantially cheaper than diesel fuel,"



Collins said. "The fuel is cleaner than gasoline or diesel and environmentally friendly since you don't have the emissions associated with those fuels."

A diesel-fuel purchase is almost four times more expensive than one of liquefied natural gas. Since August, MLGW has sold 1.1 million gallons of natural gas, bringing in a reported \$700,000. This year, MLGW expects to increase LNG sales to almost \$5 million, which represents an increase of almost 600 percent.

MLGW ventured into the liquefied gas retail market after considerations that there are no other facilities with the ability to produce LNG within hundreds of miles.

"A lower gas bill is a very strong possibility," Collins said. "Any profit that is made will benefit the customer in either gas rate decreases or avoiding any future rate increases."
